PACPI'S SERVICES ARE DESIGNED TO PROVIDE A HIGH LEVEL OF SUPPORT TO HIV-POSITIVE WOMEN WHO ARE NEWLY DIAGNOSED, HIV POSITIVE AND PREGNANT OR RECENTLY DELIVERED WOMEN NAVIGATING THE COMPLEX HEALTHCARE SYSTEM THAT DOES NOT EASILY ADDRESS THE INTRICATE MEDICAL AND HEALTHCARE NEEDS OF HIV POSITIVE WOMEN AND THEIR FAMILIES. THE HOTLINE RECEIVED REPORTS OF 53 OF THE 135 KNOWN HIV-POSITIVE PREGNANT WOMEN DELIVERING IN THE STATE OF ILLINOIS. THESE CALLS REFLECT BOTH THE REPORTS OF POSITIVE RAPID HIV TESTS AND CALLS REQUIRING ASSISTANCE LINKING KNOWN POSITIVE PATIENTS TO CARE.
